**The Master of Pharmacy (M.Pharm) Course Regulations, 2014**

**No. 14-136/ 2014-PCI.**—In exercise of the powers conferred by Sections 10 and 18 of the Pharmacy Act, 1948 (8 of 1948), the Pharmacy Council of India, with the approval of the Central Government hereby makes the following regulations; namely—

**Chapter - I**

**1. Short Title and Commencement**

1. These regulations may be called the Master of Pharmacy (M.Pharm) Course Regulations 2014.
2. They shall come into force on the date of their publication in the Official Gazette.
3. Master of Pharmacy (M.Pharm) shall consist of a certificate, of having passed the course of study and examination as prescribed in these regulations, for the purpose of registration/addition of qualification as a pharmacist for practicing the profession under the Pharmacy Act, 1948.

**2. Duration of the course**

- a) The duration of the M.Pharm course shall be of two academic years full time with each academic year spread over a period of not less than two hundred working days.
- b) The study of M.Pharm course shall be of annual system which includes M.Pharm (Part-I) extending for 12 months from the commencement of the academic term and M.Pharm (Part-II) of another 12 months duration.
- c) At the end of M.Pharm (Part-I) there shall be a university examination of M.Pharm (Part-I). At the end of M.Pharm (Part-II) the candidate shall submit a dissertation on the topic approved by the university.
